### **Business/Nonprofit Partnership Agreement**

Prince George's Community College (PGCC)

**Mission of Prince George's Community College**: Prince George's Community College provides high-quality, transformative learning experiences that enrich lives and empower students to earn credentials leading to personal development, professional advancement, and economic prosperity.

The Applicable Prince George's Community College Strategic Goal: Reimagining workforce innovations and partnerships. PGCC Business Partnership Agreements are available to local businesses and non-profit organizations who, in PGCC's sole determination, have the capability to provide items, internships, exhibitions, workshops, and/or other programs of academic value to PGCC students.

#### **Purpose of the Agreement**

This agreement is designed to create a collaborative relationship between Prince George's Community College and Culture Wireless Inc. DBA Moolah Wireless/Cover360ixty, referred to herein as the "Partner". Nothing in this agreement shall be deemed to constitute a legal partnership or joint venture between the parties or constitute any party to be the agent of or act as an authority of the other party in any way.

In consideration of the provisions herein, the parties hereby agree to the following collaboration for a duration of six months from the date of final party signature, for the distribution of tablets to those living in Foster Care, those experiencing homelessness, and Supplemental Nutrition Assistance Program (SNAP), Medicaid, Temporary Cash Assistance, and Free and Reduced Meal recipients, who are students and/or in community facing programs operating at Prince George's Community College.

# **Prince George's Community College Representations:**

In exchange for the Partner's reasonable efforts to provide tablets to eligible Prince George's Community College students or participants in community facing programs operating at Prince George's Community College (PGCC), PGCC will provide the Partner with the following benefits to the extent permitted by law:

### **Partner Representations:**

In exchange for the benefits listed above, and subject to all PGCC policies and procedures, Partner will provide tablets to those deemed eligible for the Affordable Connectivity Program (ACP) who haven't received a tablet in the last calendar year from another ACP provider that are living in Foster Care, those experiencing homelessness, and Supplemental Nutrition Assistance Program (SNAP), Medicaid, Temporary Cash Assistance, and Free and Reduced Meal recipients, who are students and/or in community facing programs operating at Prince George's Community College.

## Partner understands and agrees to the following additional terms and conditions:

- The parties will collaborate on the development of all marketing, recruitment, and publicity materials and statements related to developing the items listed under this agreement.
- The College will publicize the program in the news release and the newsletters by sharing a link that will be sent by the Partner for the students/participants to fill out. The students/participants will fill out the link on their own, and will provide the needed documentation to confirm their eligibility to the Partner. The Partner will then verify the students'/participants' eligibility and will ship the tablets to their homes. The exception will be those students/participants who will receive their devices at an outreach event, that will be coordinated by Prince George's Community College. For those students/participants who will receive their tablets at an outreach event, the Partner will ship a pre-determined number of tablets directly to the College for distribution to those specifically identified students/participants.
- Where Partner seeks to conduct activities that may bring its employees, contractors, or agents in direct contact with PGCC minor students, such employees, contractors, or agents may be required to pass a fingerprinting criminal background check conducted by the Maryland Criminal Justice Information System (CJIS) and the FBI, as well as a check of applicable state sex offender registries.

#### **Miscellaneous:**

Nothing in this agreement shall be construed as obligating the payment of any funds from one party to the other.

Either party may terminate this agreement at any time for any reason upon notice to an authorized representative of the other party.

This agreement represents the final and complete understanding of the parties and may not be amended or modified except by a writing signed by both parties.
