We are starting your Supplemental Security Income (SSI) payments again because you gave us the information we needed.

We plan to increase your monthly Supplemental Security Income (SSI) payment from \$841.00 to \$914.00 beginning January 2023. The amount will change because your situation changed. You will continue to get the new amount each month unless there is a change in the information we use to figure your payment.

When You Will Receive Your Payments

You will receive a payment of \$1,682.00 by December 15, 2022. This payment covers November 2022 through December 2022. You will receive your regular monthly payment of \$914.00 around January 1, 2023, and on the first of each month after that.

Information About Your Back Payments

Based on our rules, you are not eligible for SSI for any month in which you have resources over \$2,000.00. We do not count SSI back payments as a resource until 9 months after they are received.

Any part of your SSI back payment of \$1,682.00 that you still have on October 1, 2023, will count as a resource. If this money brings your total resources to more than \$2,000.00, you will not be eligible for SSI.

Your Reporting Responsibilities

Your SSI payments may change if your situation changes. You are required to report any changes that may affect your SSI no later than 10 days after the month the change takes place.

Please call 1-800-772-1213 (TTY 1-800-325-0778) or contact your local Social Security office to report any of the following changes:

- You start or stop work, or your wages increase or decrease
- Your bank account balance goes over \$2,000.00
- You move
- Anyone else moves into or out of your household
- Someone in your household dies
- You marry, separate, or divorce
- Income or resources change for you or members of your household
- Your medical condition improves
- You leave the United States and expect to be gone for a full calendar month or for 30 consecutive days
- You are in a hospital, jail, or other institution for a full calendar month
- You have a felony or arrest warrant for escape from custody, flight to avoid prosecution or confinement, or flight-escape
