Based on your application or receipt of direct certification Medicaid-Reduced, your student(s) have been approved for **REDUCED LUNCH** in Wichita Public Schools for the **2022-23** school year. This year, all students receive **FREE BREAKFAST**. Eligibility for meals is good through the remainder of the school year. The reduced price for lunch is \$0.40. We encourage you to pay in advance to keep your student(s) account current, for quicker meal service. For your convenience, payments can be made at <https://family.titank12.com>. If you wish to share your student(s) meal status to reduce school fees, take this letter to your student's school at the time of fee payment and complete the Consent for Disclosure form during online enrollment to designate which school fees to be considered for reduction.

If any student in your household that will attend Wichita Public Schools does **NOT** receive a status letter, any information listed is incorrect, you do not want your child to receive meal benefits, you have any questions or do not agree with the decision, please contact the Nutrition Services Department at 316.973.2160 or kidseat@usd259.net. You may apply/reapply for meal benefits at any time during the school year. If you are not eligible now but have a decrease in household income, have an increase in household size, qualify for FA, TAF or FDPIR, or you believe your household size and income would qualify for free meals, you may complete a new application at that time.
