The program, called the Florida Tax Credit Scholarship, was created in 2001 and is run by a nonprofit, Step Up For Students. The scholarship is based on income and not on the academic performance of either the student or the public school. The scholarship is worth more than \$4,000 and can be used at about 1,300 private schools statewide; a separate \$500 transportation scholarship is available to attend a public school in another county.
