#### **Important note about the Parent Weekly Responsibility:**

##### **ACCESS INITIATIVE INFORMATION:**

Through the federal Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA), DECAL has received funds to help eligible Georgia families (negatively impacted by the pandemic) pay for child care. Normally, CAPS has a maximum payment amount that is paid to the provider, which is based on the location, child care provider type selected, age of child, and type of care. Families determined eligible for CAPS would typically pay a portion of the cost of child care; this is what CAPS calls the Family Fee or Parent Weekly Responsibility. With CRRSA funding, **DECAL will support families through an initiative called ACCESS - Awarding Child Care Education Scholarship Supplements. CAPS family fees will be waived under the ACCESS initiative May 17, 2021 through service period ending October 1, 2023. Families will not pay their provider any tuition related fees or co-payments for child care services.** CAPS will pay child care providers their full published rate for the type of care provided, including the family fee. However, the provider may charge families for costs outside of child care services, such as transportation or meal fees. Although the scholarships do not reflect the payment changes provided by the ACCESS initiative, you will benefit from ACCESS throughout the period you are eligible for child care assistance. ACCESS initiative payments supplement the published CAPS reimbursement rates.

Your child should attend the child care program regularly. Your child is required by the child care program and state rules and regulations to be signed in and signed out of the child care program every day they attend. Failure to sign your child in and out could result in the child care program having to pay back funds paid to them for your child's care. If your child must be absent, give the provider as much advance notice as possible.

Payments will be made in accordance with the child's attendance and the care authorized by this scholarship.

If your family is eligible for a CAPS scholarship, you must enroll your child in a CAPS participating child care provider. If a child care provider you selected is no longer a participating CAPS provider, you will be required to select a new child care provider to continue receiving CAPS assistance.

Clients must report changes in circumstances to the CAPS program within 10 calendar days of becoming aware of the change.

Providers must notify MAXIMUS of any changes in their information immediately.
